NEW BUSINES

1. <u>Special use for a "food store" at 12126 Vincennes Avenue in the R-1 Single-Family</u> <u>Residential District.</u> [Blue Station Mart, Inc.]

Chairman Johnson opened the public hearing at 7:04 p.m. All potential witnesses were sworn in.

Blue Station Mart, Inc. owner, Abdulrus Abdul, explained to the Committee that he hopes to continue the previous use of this address for a food store. He presented a petition from 100-150 residents supporting his application. He will not be serving alcohol, and he removed the lottery and slot machines. Coppari explained that those uses would be accessory if he later wanted to reinstall the machines. Abdul will serve tobacco products, though he stated those sales will not exceed 10-20 percent. Coppari mentioned that he has been working with Abdul to fix certain issues around

the business to comply with building codes. Coppari added that there is enough parking, when combined with the daycare next doo

There were no public comments. Johnson closed the public hearing at 7:18 p.m.

2. <u>Special use for a "cultural institution" at 2451 Vermont Street in the UTOD District.</u> [Blue Island Fire Museum and Educational Center]

Ken Jellema and Betty Nagel spoke on behalf of the Applicant. This idea started in 2017, as a way to put Old Bess on display. The Museum will be small, but large enough to house the firetruck. The Museum organizes hope to include the upstairs in future remodeling, but visitors will be kept on the first floor for the time being. Coppari provided more history, including the recent map amendment that placed this parcel in the UTOD to promote mixed development. The Board asked several questions about how the museum will operate.
