**A RESOLUTION REGARDING SURFACE TRANSPORTATION PROGRAM
FUNDING FOR DIVISION STREET RECONSTRUCTION
FROM VERMONT STREET TO BROADWAY STREET**

WHEREAS, the City of Blue Island is a member of the Southwest Conference of Mayors Transportation Committee; and

WHEREAS, the Southwest Conference of Mayors requires a “local match” resolution of all project sponsors according to its Surface Transportation Program (STP) Policy; and

WHEREAS, the City of Blue Island Division Street Reconstruction STP project will be considered by the Southwest Conference of Mayors; and

WHEREAS, the City of Blue Island is capable, willing and able to fund the required local match (20% of the total Phase I Engineering, Phase II Engineering and Construction costs) during the programmed year.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and the City Council of the City of Blue Island, Cook County, Illinois as follows:

SECTION 1. The recitals set forth above are incorporated herein and made a part hereof.

SECTION 2. That the Mayor and City Council of the City of Blue Island, Cook County, Illinois do hereby authorize the expenditure of funds from the City of Blue Island’s local funds for the Division Street Reconstruction STP Improvement to be funded through the Southwest Conference of Mayors Surface Transportation Program.

SECTION 3. This Resolution shall be in full force and effect from and after its passage, approval and publication as required by law.
